High Risk Cargo

- Precious metals and/or stones and/or articles made of or containing precious metals and/or stones
- living creatures
- watches with a retail value exceeding 250 SDRs each
- processed tobacco and/or tobacco products
- mobile telephones, smart phones, electronic organisers, palm-top computers (but not laptop, tablet and/or slate computers) and/or similar equipment
- microchips, microprocessors, memory in component form and central processing units and/or similar

Thief Attractive Cargo

- Bottled perfumery
- Bottled spirits
- Clothing and/or footwear
- Televisions, digital cameras, audio visual equipment, games consoles and/or associated pre-recorded media
- Computer equipment (including laptop and/or tablet and/or slate computers) and/or components, associated software, electrical and/or electronic accessories
- Non-ferrous metals but not articles made of or containing precious metals

Key Exclusions

- Natural Deterioration of Goods
- Defective or Inadequate Packaging
- Excluded Goods e.g. Cash, Bonds, Living Creatures, Dangerous Goods
- Fines & Penalties
- Loss of Market Value from Late Delivery
